## **Military Leave**

Employees called to military service in the Military Reserve or National Guard will receive the period of time on active duty up to thirty (30) days with pay. A schedule of duty time

with as much advance notice as possible should be given to the supervisor. An employee may choose one of the following options:

- a) Present military pay to the library and receive full pay from the organization.
- b) Use accumulated annual leave and retain the military pay
- c) Take leave without pay and retain the military pay (K.S.A. 48-222).

An employee returning from military leave shall be entitled to restoration to the former position or position of like pay and responsibility. The employee must make application for reinstatement within thirty (30) days after release from activity duty (K.S.A. 73-73123).

## Military Service Leave

An employee who enters the military service or extended active duty shall be granted a leave of absence without pay or benefits. The employee is entitled to reinstatement of his/her position upon discharge from military service. Any employee who needs a leave of absence for military service or training shall be given all rights required by law, including the Uniformed Services Employment and Reemployment Act of 1994. The employee must notify the Library Director of the need for military leave as soon as possible. The Director will schedule a meeting with the employee to discuss the military leave.

## And Goddard's
